## Summary Of Inquiry Process – refer Appendix I

- The type of inquiry and appropriate department to run it are decided upon after discussions between Ministers and officials, with advice from Crown Law Office (CLO) and State Services Commission (SSC) as required.
- Appointments to a Commission are decided by Ministers, with advice from the SSC and other relevant agencies. Where a current or retired member of the judiciary are sought to be appointed, the Attorney-General is responsible for approaching the Chief Justice. If needed, a Counsel Assisting is appointed by or seconded from the CLO after discussion with the prospective Chair.
- Officials from the department responsible for the subject matter of the inquiry draft the
  preliminary Terms of Reference, with advice sought as required from CLO, Department of
  Internal Affairs (DIA), SSC, Treasury and Department of Prime Minister & Cabinet (DPMC).
  After viewing by the Chair, these are provisionally approved by Cabinet along with an
  interim budget prepared by DIA.
- The Attorney-General instructs the Parliamentary Counsel to incorporate the Terms of Reference into the Warrant. Further feedback from the other drafting departments and Ministers is obtained before the final wording is confirmed. Parliamentary Counsel instructs the NZ Gazette Office at DIA regarding publication of the approved Warrant in the NZ Gazette as soon as consent is obtained from the Governor-General.
- The way the inquiry is to be conducted and the Commission is to be run are decided by the Chair and Commissioners. The Commission in consultation with Counsel Assisting decides requests for party status and procedures. Procedures are discussed with interested parties by Counsel Assisting. If necessary, approval to a revised budget is sought from Cabinet via the DIA Liaison Officer.
- The Commission's Executive Officer is formally appointed by the Secretary for Internal Affairs. The remainder of the secretariat are selected by the Executive Officer and appointed by the DIA Liaison Officer under delegation.
- Delegations are obtained from the Minister of Internal Affairs by the Secretary for Internal Affairs and sub-delegated to the DIA Liaison Officer and Executive Officer.
- Setting up the Commission's offices and making all administrative arrangements, including
  matters relating to the hearings, are done by the Executive Officer. The Information Officer
  oversees information management with support from the Secretariat.
- Once all information and evidence has been gathered and all parties heard, Commissioners
  draft the report under the leadership of the Chair. Adverse comments are referred to the
  parties concerned for review before the report is finalised and presented to the GovernorGeneral.
- The Executive Officer manages publication of the report and ensures archiving of records.
   A review of how well the inquiry process ran is provided by the Executive Officer to Internal Affairs.

### 1: A Brief History of Commissions of Inquiry

- 1.1 The introduction of Commissions into modern legal history has been equated with the signing of the Domesday Book in the 11th century. The creation of the Domesday Book was the first time the Crown had examined its own workings and modified its powers as a result. It was the result of research and recommendations by agents of the Crown and is referred to as perhaps the first "Royal Commission".
- In 12th Century Britain, eyres ("circuit courts") were dispatched by the Crown to transact judicial and financial business in the counties of England. These duties were officially deemed "Commissions", with their authority constituted by the warrant or letters patent that each representative of the Crown received. Such Commissions evolved into the standard method by which the judiciary exercised its powers across England on behalf of the Crown. Since their introduction, the main purpose of Commissions has been to assist the functioning of Government by ensuring an appropriate balance is maintained between the rights of the citizenry and the duties of the Crown.
- Commissions of Inquiry were introduced in New Zealand in 1867 under the Commissioners' Powers Act 1867. This Act gave Commissions of Inquiry the power to summon witnesses and pay their expenses, examine them under oath, and require production of documents. It applied to boards or commissions appointed by the Governor-General in Council under other statutes. The Act was extended in 1872 and replaced in 1903 by the Commissioners' Act, which gave more comprehensive powers to Commissioners and also specified the purposes for which a Commission could be set up. In 1905 the 1903 Act was amended to allow judges on commissions to exercise their Supreme Court powers. The 1905 amendments also extended to covering Royal Commissions appointed under the Letters Patent, where previously the application of the various Acts to Royal Commissions had been unclear.
- 1.4 The Commissions of Inquiry Act 1908 consolidated the 1903 and 1905 Acts and remains in force today, with various amendments (see **Appendix II**).
- 1.5 A number of Commissions have been subjected to judicial review, both during the course of the inquiry and after they have reported. These reviews have defined the meaning and extent of the Act and provide a picture of the sorts of problems that can befall Commissions of Inquiry. The main findings are summarised below.\* An analysis of some of the key clauses in the Act is included in **Appendix VI**.

#### 1.6 Cock v Attorney General [1909] 2 NZLR 405

This case arose from a Commission of Inquiry convened to investigate alleged bribery of the members of a district Licensing Committee. One of these members successfully challenged the legality of the Commission's Warrant.

The Court found that Commissions that purport to exercise judicial functions are illegal. Commissions are not courts.
